



Business Social Compliance Initiative (BSCI)

BSCI is a leading supply chain management system that supports companies to drive social compliance and improvements within the factories and farms in their global supply chains. BSCI implements the principle international labour standards protecting workers' rights such as International Labour Organization (ILO) conventions and declarations, the United Nations (UN) Guiding Principles on Business and Human Rights and guidelines for multinational enterprises of the Organization for Economic Co-operation and Development (OECD). www.bsci-intl.org



Business Environmental Performance Initiative (BEPI)

BEPI enables companies to manage and improve the environmental performance of their global supply chain through a supported and tailored management system approach. BEPI uses industry best practices alongside practical technical expertise to support companies in developing supply chain visibility and meet the increasing environmental regulatory and stakeholder requirements. The basis of the BEPI Framework is built on the Global Social Compliance Programme (GSCP) Environmental Reference Tools, and it is also aligned with leading environmental standards such as the Global Reporting Initiative (GRI). www.bepi-intl.org
